<b>PROP#</b>	<b>RECOMMENDED POSITION</b>	<b>QUALIFIED BALLOT MEASURES</b>
<b>G</b>	Support	Local commercial cannabis taxation measure. Establishes local tax to support essential services in unincorporated Nevada County with locally-controlled funding.
<b>1</b>	Support	Veterans and Affordable Housing Bond Act of 2018. (SB 3, Chapter 365, Statutes of 2017)
<b>2</b>	Support	No Place Like Home Act 2018 (AB 1827, Chapter 41, Statutes of 2018)
<b>3</b>	No Consensus	Authorizes Bonds to Fund Projects for Water Supply and Quality, Watershed, Fish, Wildlife, Water Conveyance, and Groundwater Sustainability and Storage Initiative Statute.
<b>4</b>	Support	Authorizes Bonds Funding Construction at Hospitals Providing Children's Health Care. Initiative Statute.
<b>5</b>	Oppose	Changes Requirements for Certain Property Owners to Transfer Their Property Tax Base to Replacement Property Initiative Constitutional Amendment & Statute.
<b>6</b>	Oppose	Eliminates Recently Enacted Road Repair and Transportation Funding by Repealing Revenues Dedicated for Those Purposes. Requires Any Measure to Enact Certain Vehicle Fuel Taxes and Vehicle Fees Be Submitted to and Approved by the Electorate. Initiative Constitution Amendment
<b>7</b>	Support	Daylight Savings Time (AB 807, Chapter 6, Statutes of 2018)
<b>8</b>	Support	Authorizes State Regulation of Kidney Dialysis Clinics. Limits Charges for Patient Care. Initiative Statute.
<b>10</b>	Support	Expands Local Government's Authority to Enact Rent Control on Residential Property. Initiative Statute.
<b>11</b>	Oppose	Requires Private-Sector Emergency Ambulance Employees to Remain on Call During Work Breaks. Changes Other Conditions of Employment. Initiative Statute.
<b>12</b>	Support	Establishes New Standards for Confinement of Certain Farm Animals; Bans Sale of Certain Non-Complying Products. Initiative Statute.
