We are at slot #16 on West Broad Street. Wear a Democratic or blue t-shirt, and don't forget water, hat and sunscreen!



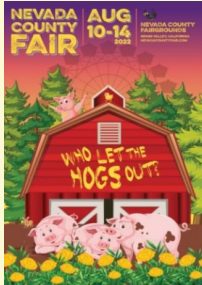

Election Results June 24th - All Ballots Counted in Nevada County

37,985 ballots out of 75,368 were cast, for a 50.4% voter return. This is low for Nevada County, but we have the 7th highest turnout in the state, just behind six other mountainous counties. The results will be certified at the end of June.

Natalie Adona won her seat as Nevada County Clerk Recorder/Registrar of Voters by a landslide--67.88%--thereby discouraging, we hope, using hit pieces in this county! Sue Hoek also won her race handily, receiving 82.59% of the vote. Lisa Swarouth just missed winning the primary outright as she received 48.39%, just shy of the 50% plus 1 needed. Keep an eye out for her name on the ballot in November.

Rob Tribble won the Nevada County Auditor-Controller seat, but his opponent recently filed a request challenging his qualifications for that office. Watch this space for further news on this one! For more information: [Challenge to Tribble](#)
